# Animal Activities Licence Fees 

## April 2023 to March 2024

## Application and Grant Fees

When applying for a licence under the Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018, the applicant must pay the relevant Application fee shown below, this must be paid at the time of application. This fee is non-refundable.

The Application fee covers the cost of administering the application and carrying out one inspection to determine whether a licence can be granted or not. When the relevant premises has been inspected and a decision is made that a licence can be issued, the officer who has carried out the inspection will also carry out the required assessment of risk which will determine the star rating that will apply to the licence and the length of time the licence will be issued.

The Grant fees cover the costs of on-going compliance and enforcement activities, including unannounced inspections and are only chargeable to successful applicants. The Grant fee must be paid at the time of licence issue.

In certain circumstances a vet fee is chargeable. A council appointed vet will accompany officers on inspection and the vet fees will be re-charged to the applicant on receipt of the vet invoice by the council. Vet fees are set by the appointed vet.

A small business discount applies in the circumstances outlined in column 2 below and is applied to give a $50 \%$ discount on the Grant Fee
If applying for a licence to carry out more than one licensable activity, a discount of $50 \%$ of one Grant fee will be applied.
A licence holder may apply to vary their licence, for example to increase the number of animals on their licence or to include a new licensable Activity
