

NOTICE OF ELECTION

Election of a Member of Parliament

For the Area of

Chester South and Eddisbury Constituency

To be held on

Thursday, 4 July 2024

1. An Election is to be held for One Member of Parliament to serve Chester South and Eddisbury.
2. Nomination papers can be obtained from the (Acting) Returning Officer who will, at the request of an elector for any electoral area, prepare a nomination paper for signature.
3. Nomination papers must be delivered to the (Acting) Returning Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA on any day after the date of this notice between the hours of **10am** and **4pm** but no later than **4pm on Friday, 7 June 2024**.
4. The £500 deposit can be paid by legal tender or by means of a banker's draft or, with the Acting Returning Officer's consent, in any other manner, including by debit or credit card or the electronic transfer of funds.
5. If any election is contested the poll will take place on **Thursday, 4 July 2024**.
6. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Wednesday, 26 June 2024**. Applications can be made online: <https://www.gov.uk/register-to-vote>
7. New applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA by **5pm on Wednesday, 19 June 2024**. You may apply online or download a form at <https://www.gov.uk/apply-postal-vote> or call the Elections Team on 01244 977084.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document, valid for this election, must reach the Electoral Registration Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA by **5pm on Wednesday, 26 June 2024**. You may apply online or download a form at: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
9. New applications to vote by proxy at this election must reach the Electoral Registration Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA by **5pm on Wednesday, 26 June 2024**. You can find information and, dependent upon your proxy type, apply online or download a form at: <https://www.gov.uk/how-to-vote/voting-by-proxy>
10. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA by **5pm on Thursday, 4 July 2024**. The physical incapacity must have occurred after **5pm on Wednesday, 26 June 2024**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday, 26 June 2024**.
